**Cynthia E. Hudson, Esq.** is currently Chief Deputy Attorney General of Virginia. She was appointed to that post in January, 2014. Ms. Hudson previously served eight years as city attorney for the City of Hampton, Virginia. Prior to her appointment as city attorney, Ms. Hudson had been a Deputy City Attorney for Hampton. Ms. Hudson's spent her early law career in private practice in the labor and employment law litigation section of McGuireWoods, LLP in Richmond, Virginia. She served also as Director of Personnel Policy and Programs for the Virginia Department of Personnel and Training. A native of Nottoway County, Virginia and a product of its public school system, Ms. Hudson received her undergraduate degree from Virginia Commonwealth University and her law degree from the College of William and Mary, where has been an adjunct law faculty member teaching state and local government law.

Michael J. Coker, Sergeant (Ret.) is a 20 Year Veteran Portsmouth Police Department. After retirement Sgt. Coker fulfilled a career goal to be an international motivational speaker in the area of Leadership and Domestic Violence/Homicide Investigations. Sgt. Coker lectures in classes and at seminars all across the United States on Domestic Violence and Domestic Homicide cases. As a "Qualified Expert Witness in Domestic Violence" District and Circuit Courts of VA, he testifies to and investigates cases. He is the Director of Coker Training and Associates; and, he is a National Instructor/Consultant who trains police officers on various topics. He is a frequent guest lecturer at New York State Police Homicide Conference, Delaware State Police Conference and a past Board Member of the Help Emergency Response (HER) battered women shelter in the city of Portsmouth.
